HOW IT WORKS

Turning **tax liability** into **low income** scholarships:

First, identify your company's corporate income tax liability and determine how much you would like to donate vs pay to the state this fiscal year.

Complete the Donation Request Form (attached) or call 928-782-5786 for assistance.

Submit the Donation Request Form to STAY no later than June 20th.

STAY will submit a Donation Approval Request to the ADOR.


ONCE YOU'RE APPROVED

ADOR will respond to the request for pre-approval within 20 days. STAY will notify your company of their approval and you will have 20 calendar days to submit funds to STAY.

Once STAY receives your funds ADOR will be notified and STAY can provide your company a receipt to claim your tax credit (Arizona tax Form 335 or 341 with your corporate return (Form 120).

STAY then issues tuition scholarships to qualifying students! **YOUR TAX DOLLARS OPTIMIZED IN YOUR COMMUNITY!**
