PROCEDURES

You will receive a receipt to be used in lieu of the payment of Arizona Income Tax or Federal Income Tax deduction.



Get a dollar-for-dollar tax credit on your Arizona Income Tax return up to the amount of your income tax, or the amount of your donation, whichever is less!



By law, at least 90% of all tax credit dollars must be awarded as scholarships to students attending private schools.

The law also allows a carry-over of any unused portions of the credit for up to five years.

Donations are applied to the "Original Tax Credit" until the donor reaches their "tax credit limit" for the tax year. At that time, the excess dollars are applied to the new "Switcher Individual Tax Credit" until that credit is also maxed for the tax year.

COMBINED LIMITS change annually. Please visit www.azstay.org for annually updated amounts. Original Individual Tax Credit (Claimed on Arizona Form 323) limits change annually. Please visit www.azstay.org for annually updated amounts. Switcher Individual Tax Credit (Claimed on Arizona Form 348) limits change annually. Please visit www.azstay.org for annually updated amounts.

Donations are used for tuition grants for K-12 students attending private schools in Arizona. Tuition grants are awarded without regard to the student's race, color, gender, handicap, familial status or national origin. At least ninety percent of the donated funds are used for the tuition grants. Decisions awarding tuition grants are the sole responsibility of the association. Admission decisions are the exclusive responsibility of the school. Donations must be postmarked or delivered to the association by April 15 to be claimed as a credit for the tax year. Donations made between January 1 and April 15 may be used as a credit for the current tax year or the previous tax year but not both. They may only be used as a Federal deduction in the actual year the donation was made. Consult with your tax professional regarding the deductibility of a tax credit donation.
